He also wanted to know if the Commissioners were going to keep the MOU with Worley Fire once the house was completed. It was his understanding that once MKI was on its feet that they would break away and stand on there own.

CHAIRMAN MUNDT stated that he was very pleased with the relationship, things are running far more seamlessly then before., if it was up to him we would continue.

James King feels like the lines have become very bleared, and that merger might be in the future. A lot of the neighbors that he has talked to think that everyone might not be for that.

COMMISSIONER HANSON wanted to clarify our MOU with Worley Fire for management oversight. We are paying \$69,000 per year for a Fire Chief and Deputy Chief, if we did not have the MOU we would have to hire a Chief and that would cost \$120,000 per year to do what Worley Fire is providing for us right now. It has worked out in my opinion, we are training together and running mutual aid calls together.

CHIEF TEMPLETON stated that volunteers get preference points for hire. Currently there are calls that we are not going on, for a manager that is not good. 24 hours coverage is what we need, we have to put people on calls to take care of our district.

Randy Opp 5142 Mica Springs Rd - Thanked Gretchen Hauser for her years of service and the Commissioners for their willingness to dialog, that was not always the case in the past. Thank you.

Monthly Report

1. Responses:

a. We are at 146 calls for the year.

2. Operations:

- a. <u>Personnel</u>: We have hired Taylor Clark as the 3rd shift person, he started on the 21st. The new hiring process we used this time was a big improvement as it brought in some very high quality candidates.
 - i. Firefighter Clark has been assigned his new employee task books and has started working on getting them completed. I anticipate about 6 weeks for him to complete all the required training before he can operate on his own.
- b. <u>Projects:</u> We are finished with hose and hydrants. We are waiting on our contractors to let us know dates for Ladder and Pump testing.
- c. <u>Isolation Protocols:</u> We are under the Kootenai County Isolation and PPE protocols. We will reevaluate our operational protocols as COVID conditions change.
- d. <u>B255</u>: The pump motor on B255 is having issues. We have replace multiple parts and it is still not running properly, we plan on swapping the pump and motor with a spare late fall.

3. Training:

i. All training has been cancelled until further notice due to isolation protocols.

4. Projects:

- a. <u>Sewer:</u> Residence sewer hookup is complete, we are working on getting the station plumbed currently.
- b. <u>Power:</u> Power to the residence is done. We are waiting on the skirting to be completed so we can get the heat/cooling unit installed.
- c. <u>Decks:</u> Supports are being placed and decks will be started after supports are finished.

- d. <u>Dirt:</u> Once all construction is completed we will finish leveling/seeding front area.
- e. <u>Signage:</u> Looks like signage will probably be deferred until spring 2021.

5. Budget:

 - i. Working on closing out the FY19/20 budget.
