1. Responses:

a. We are at 292 calls for the year.

2. Operations:

- a. <u>Personnel</u>:
 - i. FF Bauer resigned on 12/07/2021, moving to North Dakota.
 - ii. FF Prichard accepted the conditional offer, waiting on physical which is scheduled 01/04/2022
 - iii. While doing the interviews and waiting for FF Prichard to start we will have used 192 hours of overtime.
- b. <u>Decks:</u> Waiting for the weather to allow project to continue. Once we are able we will be getting holes dug and the we will set the decks.
- c. <u>early Projects:</u> Pump testing on E221, E222 and T260 was completed on Friday October 29th. Ladder testing is scheduled for late December with Underwriting Laboratories. I was quoted between \$400-\$450 by Chief Sneve. Ladder testing will take place at Worley Fire District.
- d. <u>Fire Prevention/Inspections:</u> MKI has had a total of 9 inspections from November 15th December 14th.
- e. Policies: Have been completed and need to be looked at.

4. Projects:

<u>Cascade System:</u> Passed the air quality test. The system is approved for use, I will be getting our staff trained on the cascade system.

<u>House Drainage:</u> Was completed and is functioning.

Elements Landscaping installed french drains around the house and 20 feet out. All gutter down spouts are connected to pipes that drain away from the house into the culvert that crosses under the road and over to Worley Highway.
